

#### cOAlition S

By 2020 scientific publications that result from research funded by public grants provided by participating national and European research councils and funding bodies, must be published in compliant Open Access Journals or on compliant Open Access Platforms

# The 10 principles

**O1** Authors retain copyright of their publication with no restrictions. All publications must be published under an open license, preferably the Creative Commons Attribution Licence CC BY. In all cases, the license applied should fulfil the requirements defined by the Berlin Declaration;

**02** The Funders will ensure jointly the establishment of robust criteria and requirements for the services that compliant high quality Open Access journals and Open Access platforms must provide;

**03** In case such high quality Open Access journals or platforms do not yet exist, the Funders will, in a coordinated way, provide incentives to establish and support them when appropriate; support will also be provided for Open Access infrastructures where necessary;

**04** Where applicable, Open Access publication fees are covered by the Funders or universities, not by individual researchers; it is acknowledged that all scientists should be able to publish their work Open Access even if their institutions have limited means;

**05** When Open Access publication fees are applied, their funding is standardised and capped (across Europe);

**06** The Funders will ask universities, research organisations, and libraries to align their policies and strategies, notably to ensure transparency;

**07** The above principles shall apply to all types of scholarly publications, but it is understood that the timeline to achieve Open Access for monographs and books may be longer than 1 January 2020;

**08** The importance of open archives and repositories for hosting research outputs is acknowledged because of their long-term archiving function and their potential for editorial innovation;

**09** The 'hybrid' model of publishing is not compliant with the above principles;


**10** The Funders will monitor compliance and sanction non-compliance.

# Green Open Access

- Green or self-archiving, is where an author deposits their version of their submitted manuscript (pre-print) or accepted manuscript (post-print) into their institutional repository or website (following an embargo period), and pays no charge.
- As of September 2017 all of our journals offer a zero embargo policy.
- Green Open Access is the dominant model with the US, UK and parts of Asia.
- Within the UK, to be eligible for the Research Excellence Framework (REF) 2021 authors must make a 'closed deposit' within their institutional repository within 3 months of the acceptance date.
- Authors must refer to the open access policy of the journal / publisher, for guidelines of where they are permitted to post a green version of their article.



# Green Open Access

Where most mandates for Green Open Access are regional (i.e. governmental) or institutional (University or department) some research areas have a strong preprint culture and have developed discipline led repositories. Some of the most influential repositories include:

# Gold Open Access

- Gold or 'author pays', is where authors pay an Article Processing Charge (APC) to enable their published article to be immediately available and free of any paywall or subscription charges.
- Articles are mainly published via a CCBY 4.0 licence. This means they are free to read, distribute, reuse.
- Variations in CCBY licence types offer a non commercial (CCBY NC) and / or non derivative (CCBY ND) alternative.
- Gold Open Access can be offered via:
  - Hybrid Journals
  - Fully Open Access Journals
  - "International Journal of Climate Change Strategies and Management"
- Emerald's APC has a set price of £2,400/\$3,240/€2,880



# Platinum Open Access

- Platinum Open Access where the costs of publishing an Open Access
  Journal are sponsored by a third party (i.e. institution / association). All
  articles published in that journal are automatically published as Open Access,
  with no cost to the author.
- Emerald offers a platinum Open Access model via Emerald Publishing Services (EPS).
- Emerald recognises that associations, universities and organisations strive to highlight the quality and breadth of research undertaken in their communities, and has developed EPS to enable independent journals to reach a global audience.



# **Emerald Open Research**

Emerald Open Research is an **open access platform** being launched by Emerald Publishing in partnership with F1000. The platform will allow authors to publish their research within an **average of seven days** of submission and achieve transparency through an **open peer review process** and **open data policy**, meaning all data sets as well as the research will become freely available to reuse, repurpose, and redistribute.

The platform will follow the same publishing model as F1000Research which has also recently been adopted by Wellcome Open Research and Gates Open Research.


